

UNIS Publishing Agreement

*This Publishing Agreement (**the Agreement**) applies to scientific reports, field reports, PHD- master's- and bachelor's theses or other written works (as applicable) written by students attending UNIS – The University Center in Svalbard, either as enrolled students or guest students.*

*The Publishing Agreement is entered into by the student (**the Author**) either in connection with the submission of material for publishing explicitly setting out such effect, or as part of other agreements. For the avoidance of doubt, a contractual arrangement setting out the binding effect of this Agreement must exist for a person to be bound by it, and the terms herein shall not apply in the absence of such contractual arrangement.*

1. License to publish in electronic form

The Author grants UNIS a free, non-exclusive and otherwise unlimited license to make the Author's written work (hereinafter the **thesis**) available in the institutional archive(s) of UNIS, which includes publication on the Internet. UNIS may use third party services and databases for this purpose, such as but not limited to publication in the Norwegian national research archive (NVA) and/or Alma/Oria (library systems). UNIS may further make the thesis available on its website and in other databases or websites containing research connected to UNIS.

Author accepts and acknowledges that such publication has the effect that third-party sites may hyperlink to the thesis, and that the thesis may be included in internet search engines, including metadata such as author, title, publication year and keywords.

2. License to print and make physical copies

Author grants UNIS a free, non-exclusive license to make isolated and occasional paper prints and physical copies of the thesis.

However, UNIS shall only have the right to use such prints or copies for non-commercial use, and not for any publishing-like purposes. Publishing-like purposes shall include the making of books or book-like products, as well as inclusion in anthologies or other collections of written material.

3. Duties of UNIS

UNIS shall publish the thesis in the identical form as submitted to UNIS, and shall have no right to alter, change or redact information therein unless agreed with Author.

Notwithstanding the above, UNIS shall have the right to add the UNIS logo on the title page of the thesis, provided the Author has written the thesis or performed research forming basis for the thesis in whole or in part during a stay with UNIS. UNIS may also add its address as one of Author's institutional addresses if UNIS has contributed to research forming basis for the thesis. UNIS may direct the Author to submit the thesis in a form complying with these requirements.

4. Duties of the Author

The thesis submitted to UNIS shall be identical to the thesis submitted for examination, save for the addition of names, addresses, logos etc. that may have been omitted in the examination version.

The Author represents and warrants that the thesis submitted to UNIS is the Author's own original work, and that the Author has the right to grant the publications rights included herein to UNIS.

The Author shall submit a redacted version if there are elements in the thesis that the Author wants to redact from the published version. If the thesis contains elements to which third parties have rights and which is a hindrance to the publication rights granted to UNIS, the Author shall redact such elements from the thesis before submitting a copy to UNIS for publication.

If Author enters into agreement with any third party relating to the publishing of the thesis in original, altered or amended version (such as publication in journals or books), the Author undertakes to ensure that any granted rights shall not affect the rights granted to UNIS in accordance with this Agreement. In this case, UNIS can remove the thesis or add an embargo upon the author's request.

In the event UNIS is held liable by any third party for the Author's breach of the provision in this section, the Author shall hold UNIS harmless for any loss thereby caused UNIS.

5. Transfer of the Agreement

UNIS may transfer this Agreement and the rights and/or duties arising therefrom to any third party, provided the rights of the Author remains protected and enforceable either against UNIS or the assignee.

6. No obligation to publish

Nothing in this Agreement shall be interpreted as an obligation for UNIS to publish the thesis in accordance with the granted license.

7. No endorsement or liability

The publication of the thesis by UNIS in accordance with the license granted herein shall not be understood or construed as an endorsement, acceptance or approval of the contents of the thesis.

UNIS shall have no liability for any claim arising from the contents of the published thesis.

8. Termination

The Author may terminate the Agreement by written notice to UNIS, with effect 6 months after the termination has been received by UNIS.

9. No implied license. Governing Law.

No other rights than the rights specifically granted to UNIS shall be implied by this license.

This Agreement is governed exclusively by Norwegian law and jurisdiction.
